

Re: The Living Man

18. Our 'soul and Spirit' made a choice to incarnate into the form of "man", with the mother being "*First Name of Mother*", born of both the clan "*Maiden Family Name of Mother*" and the clan "*Family Name of Mother's Mother*", with the "biological father" being "*First Name of Father*", born of both the clan "*Family Name of Father*" and the clan "*Family Name of Father's Mother*" hereafter called 'the biological creators', both of which have or had physical standing upon the land at the time of the 'conception' of our living being; and
19. The living fetus into which we incarnated was born as a living being on the date known as the *Date Born in Words* day of the month of "*Month Born*" in the year of Yahuah The Almighty known as "*Year Born in Words*" on the land known as "*Ancient Name of Country/Land of Birth*"; and
20. The physical living being in which we are now incarnated is born of co-creation of both the clan "*Maiden Family Name of Mother*" and the clan "*Family Name of Father*"; and
21. The physical living being in which we are now incarnated has the blood type of *Your Blood Type*.
22. The living being in which we are now incarnated considers himself a national of the land known since Biblical times as *Ancient Name of Country/Land of Birth*; and
23. The living being in which we are now incarnated is neither alien of "*Ancient Name of Country/Land of Birth*", nor a citizen of *Ancient Name of Country/Land of Birth*, nor considers himself a citizen of any other fictitious "country"; and
24. The biological creators '*First Name of Mother*' and '*First Name of Father*' gave the living being in which we are now incarnated the appellation '*Aaa-Maiden Family Name of Mother*'; and
25. The appellation of the live-born being, as given above in the previous paragraph (24), is based upon the appellation given to the live-born biological creation by the living biological "mother" into the clan known in this case as "*Maiden Family Name of Mother*" preceded by a hyphen signifying continuity with the first name and have to be understood as the name of the living man with no surname, therefore, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*" is to be construed as the name of the living being with no surname (*Aaa-Maiden Family Name of Mother*) followed by the description of the living being's father's clan (*Family Name of Father*), this follows and obeys the ancient Ways of The Creator, Yahuah is His Name, when He describes His servants in the Scriptures by His own distinction for each, such as, Noah "the son of Lamech", Isaiah "the son of Amoz", Josiah "the son of Amon", David "the son of Jesse", and the like; and
26. This live-born being in which we are now incarnated is not in any way to be confused as being the statutory-created fiction nor any statutory-created fiction nor any estates with the name/s "*Aaa Maiden Family Name of Mother Family Name of Father*" nor "*Aaa Ddd Ccc*" nor "*Aaa B Family Name of Father*" nor "*Aaa Family Name of Father*" nor "*Family Name of Father, Aaa Maiden Family Name of Mother*" nor "*Ccc, Aaa Ddd*" nor "*Family Name of Father. Aaa, B*" nor "*Aaa, B, Family Name of Father*", et alia, nor any such upper case, "CAPITAL-LETTERED" nor lower case variation of such, in any way, including but not limited to punctuation, initials, prefixes, suffixes, titles, appendages, and the like; and
27. The living being in which we are now incarnated, so named '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", is a creation of The Creator, Yahuah is His Name; and
28. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", is not a creature, monster, animal, instrument, surety, fiction, chattel, slave, servant, subject, citizen, serf, vassal, vessel, or member of a colony, or any other similar representative of fealty or subservience;
"This living man is nobody's servant except The Almighty Yahuah, and if anybody on this Earth claims otherwise, then Yahuah The Source of all Power will be their primary adversary because this living man was already redeemed by The Creator through the payment as delivered by His Son, His Emissary, Yahusha Ha Mashiach!"

29. The 'soul and Spirit', '*Amats-Lokem*', has sole authority and control over the living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", and that authority is derived directly from The Creator, Yahuah is His name; and
30. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", is also known as '*Amats-Lokem*', an appellation with which the 'soul and Spirit' making this 'Statement and Declaration of Truth'/'Affidavit' chooses to also be identified as whilst in this realm and in this living being; and
31. The 'soul and Spirit', '*Amats-Lokem*', plays out this incarnation through the living being, and as the living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", solely with, and under the absolute authority and blessing of, The Creator, Yahuah is His Name; and
32. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", is the 'vehicle' or "vessel" of/for the 'soul and Spirit', '*Amats-Lokem*', so that the 'soul and Spirit' may observe, operate, interact and interface within, and obtain knowledge from, these dimensional domains, both physical and non physical, living and non-living dimensions of the "past", present and yet to be, "future", and cannot be, and is denied to be, claimed by, or under the authority of, any fiction, government, religion, corporation, species, and/or other entity; and
33. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", is recorded as

being a living man under the full authority of The Almighty, Yahuah is His Name, and evidenced in this open declaration as published and recorded on this webpage, available and readable for all the world to see and understand:

a complete and fully running website under the fully-qualified domain name (FQDN) "*Domain Name of Your Website*", visible to the whole wide world and readable in plain English, made possible as created by this living man, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", the declarant and affiant giving life and substance to these words in fulfillment to the Words as commanded by Yahusha Ha Mashiach; and

34. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", having reached the age of majority, that being twenty-one years, on the *Date Born in Words* day of the month of *Month Born* in the year of Yahuah The Almighty known as "*Year When You Reach 21 Y.O. In Words*", and with a body and genetic DNA free of any injections and/or external genetic modifications, **hereby claims copyright ownership** of their DNA from the biological creators, the "mother" and "father", with their consent and approval; and
35. The living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*", having reached the age of majority, that being twenty-one years, on the *twentieth* day of the month of *Month Born* in the year of Yahuah The Almighty known as "*Year When You Reach 21 Y.O. In Words*", **hereby claims copyright ownership** of the visual image of the living being, '*Aaa-Maiden Family Name of Mother*', of the clan "*Family Name of Father*" (Annexure "C"), visible on the webpage at this URL:
